## **QIAS OMAR CONTEST**

## OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

OPEN TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING RESIDENTS OF NEW YORK, FLORIDA, RHODE ISLAND, PUERTO RICO, THE U.S. VIRGIN ISLANDS, AND OTHER COMMONWEALTHS, TERRITORIES AND POSSESSIONS AND WHERE OTHERWISE PROHIBITED BY LAW), WHO HAVE REACHED 18 YEARS OF AGE BY THE DATE OF THE FIRST DAY OF THE Contest UNDER THIS AGREEMENT.

- Your Instagram profile must be set to allow public viewing
