- Start/End Dates. The SeatGeek 2019 Fan Feedback Survey Sweepstakes (the
 "Sweepstakes") begins at 12:01AM Eastern ("ET") on August 26, 2019 and ends at 11:59PM
 ET on November 3, 2019 (the "Sweepstakes Period"). The Sweepstakes is administered
 and sponsored by SeatGeek, Inc. ("Sponsor").
- 2. Eligibility. Participation is open only to legal residents of the 50 United States or the District of Columbia who are 18 or older as of date of entry. Proof of age and legal U.S. residency may be required. Void outside of the 50 United States or the District of Columbia and where prohibited, taxed or restricted by law.  - ii. **Step 2:** Respond "Yes" when asked about contest drawing participation. Enter the e-mail address to be used as a contact method should the participant be selected as a winner.
