Official Rules

- 1. Start/End Dates. Timbers Meet-and-Greet (the "Sweepstakes") begins at 9:00 a.m. Pacific Time ("PT")] on October 30, 2017 and ends at 11:59 p.m. PT on November 2, 2017 (the "Sweepstakes Period"). The Sweepstakes is sponsored by SeatGeek, Inc. ("Sponsor").
